(8) The option 'not applicable' shall be chosen if the competent authority completing the declaration is not responsible for granting pre-consents to facilities as referred to in Article 14(8) and (10) of Regulation (EU) 2024/1157.

(9) Field to be completed if a competent authority indicated 'API (local system)' in question 5(d) or 6(d).

(10) Field to be completed only if the competent authority intends to indicate a specific date following 20 working days from the submission of the declaration other than the date referred to in Article 86(2) of Regulation (EU) 2024/1157.
