4.2 Quality and importance

Este espacio alberga dos taxones del Anexo I de la Directiva aves, Falco naumanni y Ciconia ciconia. También es un importante refugio para otras especies de aves migratorias asociadas a los medios urbanos, como Apus apus, Delichon urbica e Hirundo rustica, junto con algunos residentes sedentarios como Falco tinnunculus y Tyto alba. Toda esta ornitofauna, se alimenta de los ortopteros e invertebrados de la vecina ZEPA de Campiña Sur.
